

ORDINANCE NO. 3441

ORDINANCE OF THE COUNCIL OF THE CITY OF PALO ALTO
AMENDING SECTION 18.08.040 OF THE PALO ALTO MUNICI-
PAL CODE (THE ZONING MAP) TO CHANGE THE CLASSIFICA-
TION OF A PORTION OF THE PROPERTY KNOWN AS 1400
DANA AVENUE [FORMER CRESCENT PARK SCHOOL SITE] FROM
PF TO R-1 and R-2

The Council of the City of Palo Alto does ORDAIN as follows:

SECTION 1. Section 18.08.040 of the Palo Alto Municipal Code, the "Zoning Map," is hereby amended by changing the zoning of a portion of the property known as 1400 Dana Avenue from PF (Public Facility District) to R-1 (Single Family Residence District) and R-2 (Two Family Residence District) as shown on the map attached hereto, marked Exhibit "A" and incorporated herein by this reference.

SECTION 2. The Council finds that the rezoning of the above property is consistent with the adopted Comprehensive Plan of the City of Palo Alto.

SECTION 3. The Council hereby finds that this change will have no significant adverse environmental impact.

SECTION 4. This ordinance shall become effective upon the commencement of the thirty-first day after the day of its passage.






