



BUSINESS TAX OVERVIEW

Tax Filing, Rate & Cap

Filing & Timing

- Continue existing BRC Program for all eligible businesses
- Tax imposed Jan 2023; filing and collection is due Jan 1, 2024
- First quarterly filing and collection is due April 1, 2024

Rate & Cap

- 3.75¢/sq ft monthly rate (first 24 months)
 - 7.5¢/sq ft monthly rate starting Jan 2025
- \$500,000 annual cap
- 2.5% annual CPI, beginning FY 2027
- 35-year sunset (ends 2058)



BUSINESS TAX OVERVIEW

Exemptions and Offsets

Exemptions

- Small businesses (1st 10,000 sq ft)
- Grocery Stores
- Transitory businesses (<90 days)
- Non-profit organizations
- Residential space
- Banks and financial institutions
- Some residential care or home care facilities



Offsets

- Hotel tax
- Certain sales tax paid by a business
 - Limited and only in rare cases
 - 2:1, up to 75%
- Vacant space




