



City of Palo Alto Monthly Gas Volumetric and Service Charges

Your gas bill consists of 2 types of charges: 1) a monthly service charge, and 2) “volumetric” or consumption-based charges which are based on your gas usage. The tables below show the monthly volumetric and service charges over the past two years for the **G-2 (Residential Master-Metered and Commercial)** and **G-3 (Large Commercial)** gas rate schedules.

The **monthly service charge** reflects the costs of customer service, account management, meter reading and meter equipment. The **volumetric charges** include the following 4 supply-related charges and 1 distribution charge:

1. **Commodity Charge:** This charge is based on the monthly natural gas Bidweek Price Index for delivery at PG&E Citygate, adjusted to account for delivery losses to the customer’s meter. The Commodity Charge also includes adjustments to account for Council-approved programs implemented to reduce the cost of Gas, including a municipal purchase discount¹, and \$0.055 per therm for mitigating the impact of short-term natural gas price spikes.²
2. **Cap and Trade Compliance Charge:** This charge reflects the City’s cost of regulatory compliance with the state’s Cap and Trade Program, including the cost of acquiring compliance instruments sufficient to cover the City’s Gas Utility’s compliance obligations. The Cap and Trade Compliance Charge changes in response to changing market conditions, retail sales volumes and the quantity of allowances required, and is calculated based on the Cap-and-Trade Program’s quarterly auction allowance closing prices.
3. **Transportation Charge:** This charge is based on the current PG&E G-WSL³ (Gas Transportation Service to Wholesale/Retail Customers) rate for Palo Alto, accounting for delivery losses to the Customer’s Meter.
4. **Carbon Offset Charge:** This charge reflects the City’s cost to purchase offsets for greenhouse gases produced when Gas is burned. The Carbon Offset Charge changes in response to changing market conditions, sales volumes and the quantity of offsets purchased within the Council-approved per therm cap.
5. **Distribution Charge:** This charge reflects the cost of all of the services required to move natural gas from the point of interconnection to the City’s distribution system to the customer, including the operations and maintenance of service lines and gas mains.

Your gas rate is calculated by applying the sum of the monthly service charge and volumetric charges to your consumption, which are prorated based on the number of days in the applicable billing cycle during each billing period.
